General: The primary goals of the Pax Christi Fund for Peace to contribute to the prevention, demilitarization and resolution of conflicts; to strengthen human rights, democracy and international law; and to build peace are met through grants for the work of other member organizations in the Pax Christi network.

4b (Code:) (Expenses \$ **19,739** including grants of \$ **107,783**) (Revenue \$ **101,655**)
Nonviolence Conference: co-hosted with the Vatican a landmark conference in Rome on nonviolence and just peace that brought together more than 80 people, many of whom live in contexts of war or extreme violence, to discuss the Catholic Church's ~~of~~ commitment to nonviolence. Participants shared stunning examples of effective peace-building activities and recognized the enormous potential of communities of faith to contribute to the development of new and innovative nonviolent approaches to solve crises. The conference culminated in an appeal to the Catholic Church to recommit to the centrality of Gospel nonviolence. More than 2,000 organizations and individuals have signed the appeal that asks Pope Francis to write an encyclical on nonviolence and just peace and calls on the whole institutional Church to study Gospel nonviolence and focus on the development of nonviolent tools that can help the world move into the future on a different path. Following the Rome conference, Pope Francis has explicitly taken up Gospel nonviolence in his papal messages showing that the Catholic Church is shifting to an emphasis on Gospel nonviolence and opening to the rich possibilities of nonviolence. The most spectacular outcome thus far of the Rome conference is that Pope Francis accepted a proposal from the Catholic Nonviolence Initiative to make nonviolence the theme for his 2017 World Day of Peace message entitled Nonviolence: A Style of Politics for Peace.
